HEALTH HAZARD DATA

PRIMARY ROUTE OF ENTRY: Ingestion.

SPECIAL HAZARDS: Contact with eyes or skin may cause irritation. Ingestion may cause nausea, vomiting or diarrhea.

STABILITY: Material is stable.

CONDITIONS TO AVOID: Reaction with strongly alkaline materials.

INCOMPATIBILITY (Materials to Avoid): Avoid contact with strong bases, reactive metals.

HAZARDOUS DECOMPOSITION PRODUCTS: May emit toxic phosphorus oxides if dry residue is heated to decomposition.

HAZARDOUS POLYMERIZATION: Will not occur.

STORAGE, SPILLS, AND DISPOSAL INFORMATION

SPILL OR LEAK PROCEDURES: (Steps to be taken in case material is released or spilled)

Neutralize with lime or soda ash. Take up with sand, clay, or other absorbent material.

Transfer to secure containers for proper disposal. Use personal protective equipment as outlined below.

WASTE DISPOSAL METHOD:

May be disposed of as fertilizer waste or in an approved chemical waste landfill as state or federal regulations permit regarding inorganic waste. Incineration is not practical.

CONTAINER DISPOSAL METHOD:

Triple rinse and dispose of in an approved landfill or incinerate in accordance with all applicable government regulations.

ENVIRONMENTAL: Avoid run-off into water supplies, streams, storm-water discharge, etc.

HANDLING AND STORAGE PRECAUTIONS

SPECIAL PROTECTION INFORMATION:

RESPIRATORY PROTECTION: Not normally required.
