### 3. HAZARDOUS IDENTIFICATIONS:

#### EMERGENCY OVERVIEW

Hazardous Chemical. Gray to dark brown pellet. Faint musty odor. May cause slight eye irritation with corneal injury. LD<sub>50</sub> for skin absorption in rabbits is >2000 mg/kg. Oral LD<sub>50</sub> for rats is >2000 mg/kg. Will emit toxic fumes if involved in a fire. Toxic to fish.

**POTENTIAL HEALTH EFFECTS:** This section includes possible adverse effects, which could occur if this material is not handled in the recommended manner.

**EYE:** May cause slight eye irritation with corneal injury.

**SKIN:** Essentially non-irritating to skin. A single prolonged exposure is not likely to result in the material being absorbed through skin in harmful amounts. The LD<sub>50</sub> for skin absorption in rabbits is >2000 mg/kg.

**INGESTION:** Single dose oral toxicity is low. The oral LD<sub>50</sub> for rats is >2000 mg/kg. Small amounts swallowed incidental to normal handling operations are not likely to cause injury; however, swallowing larger amounts may cause injury.

**INHALATION:** At room temperature, vapors are minimal due to physical properties; a single exposure is not likely to be hazardous.

**SYSTEMIC (OTHER TARGET ORGAN) EFFECTS:** In animals, has been shown to cause RBC, kidney and pancreatic effects.

**CANCER INFORMATION:** Tebuthiuron did not cause cancer in laboratory animals. Crystalline silica is listed as a carcinogen for hazard communication purposes under OSHA Standard 29 CFR Part 1910.1200. The clay component may contain crystalline silica, which has caused cancer in laboratory animals.

**TERATOLOGY (BIRTH DEFECTS):** For tebuthiuron, birth defects are unlikely. Even exposures having an adverse effect on the mother should have no effect on the fetus.

**REPRODUCTIVE EFFECTS:** Tebuthiuron, did not interfere with reproduction in animal studies.

### 4. FIRST AID:

**EYES:** Irrigate with flowing water immediately and continuously for 15 minutes. Consult medical personnel.

**SKIN:** Wash off in flowing water or shower.

**INGESTION:** If swallowed, seek medical attention. Do not induce vomiting unless directed to do so by medical personnel.

**INHALATION:** Remove to fresh air if effects occur. Consult a physician.

**AUTO-IGNITION TEMPERATURE:** No ignition up to 1382°F (750°C)

**EXTINGUISHING MEDIA:** Use water fog, foam, or CO<sub>2</sub> if product is involved in fire.

**FIRE AND EXPLOSION HAZARDS:** Will emit toxic vapors as it burns.

**FIRE-FIGHTING EQUIPMENT:** Wear positive-pressure, self-contained breathing apparatus and full protective clothing if product is involved in fire.

### 6. ACCIDENTAL RELEASE MEASURES:

**EXPOSURE GUIDELINE(S):** Kaolinite: ACGIH TLV is 2 mg/M<sup>3</sup> respirable, A4, for Kaolin. OSHA PEL is 10 mg/M<sup>3</sup> total dust, 5 mg/M<sup>3</sup> respirable for kaolin. PELs are in accord with those recommended by OSHA, as in the 1989 revision of PELs.

**ENGINEERING CONTROLS:** Provide general and/or local exhaust ventilation to control airborne levels below the exposure guidelines.
