### Section 4: First-Aid Measures

**Eye Contact:** Immediately flush eyes with water; remove contact lenses, if present, after the first 5 minutes then continue flushing eyes for at least 15 minutes. Obtain medical attention without delay, preferably from an ophthalmologist.

## Section 6: Accidental Release Measures

### Personal Precautions:

- Isolate area. Keep unnecessary and unprotected personnel from entering the area. Refer to Section 7, Handling, for additional precautionary measures. Keep upwind of spill. Spilled material may cause a slipping hazard. Ventilate area of leak or spill. Use appropriate safety equipment. ### Personal protective equipment:

**Eye/Face Protection:** Use chemical goggles.

**Skin Protection:** Use protective clothing chemically resistant to this material. Selection of specific items such as face shield, boots, apron, or full body suit will depend on the task. Safety shower should be located in immediate work area. Remove contaminated clothing immediately, wash skin area with soap and water, and launder clothing before reuse or dispose of properly.

**Hand protection:** Use gloves chemically resistant to this material. Examples of preferred glove barrier materials include: Neoprene, Nitrile/butadiene rubber ("nitrile" or NBR), or Polyvinyl chloride ("PVC" or "vinyl").

**Respiratory Protection:** Respiratory protection should be worn when there is a potential to exceed the exposure limit requirements or guidelines.
