Before using DuPont Matrix® SG Herbicide and Bayer “Alion” Herbicide read and follow all applicable directions, restrictions and precautions on the EPA-registered label for each product. Read and follow all label mixing instructions.

PRECAUTIONS:

It is important to use a postemergence/contact herbicide such as glyphosate or other registered postemergence herbicides to control any emerged weeds in order to obtain the best residual weed control from MATRIX® SG Herbicide.

RESTRICTIONS:

Do not apply more than 4.0 oz MATRIX® SG Herbicide per year on a broadcast acre basis. When applied as a banded treatment (50% band or less), MATRIX® SG Herbicide may be applied twice per year.

Allow a minimum of 30 days between applications of MATRIX® SG Herbicide

Weed control is limited to weeds on the DuPont MATRIX® SG Herbicide label.

The field re-entry interval (REI) for this tankmix is 12 hours. Preharvest interval (PHI) for this tankmix is 7 days for citrus fruit and 14 days for other tree crops.

Do not apply this tankmix through any type of irrigation system.
