- **Application Interval:** Do not make applications less than 14 days apart.
- **Do not** use Mustang® Max or Mustang® Maxx or products containing cypermethrin or alpha-cypermethrin on crops treated with Mustang Insecticide (combined residues may exceed the Canadian Default MRL).
