* Contains 0.83 pound of pyraclostrobin and 1.67 pounds of boscalid per gallon.

Coronet is a broad-spectrum fungicide that provides preventive seed and seedling protection against seedborne fungi causing seed decay and the soilborne pathogen *Rhizoctonia solani*. **Coronet** may be applied in conjunction with applications of other registered seed treatment and crop protection products. Make all applications according to the use directions in this label. Use the higher rates of **Coronet** when disease pressure is expected to be high.

*For control of seed and seedling disease (damping-off) caused by *Pythium* spp., use **Coronet** only in conjunction with labeled rates of mefenoxam- or metalaxyl-containing seed treatment products.
