A postemergence application of a Capreno® Herbicide + Status® Herbicide tank mixture can be applied to seed corn for improved broadleaf control. The recommended application timing ranges from V2 thru V5 corn growth stages.

- Plant corn at least 1 ½ inches deep. Corn seed must be completely covered with soil and furrow firmed.
- Apply Capreno® Herbicide spray mixtures within 24 hours of mixing to avoid product degradation.
- Avoid drift onto adjacent crops.
- For use directions, precautions and restrictions not addressed in this bulletin, follow the most restrictive directions on the respective labels of both partners in the tank mixture.
