USE PRECAUTIONS:

- Only apply *SureGuard* WDG Herbicide to healthy established dormant ornamentals.
- Do not apply *SureGuard* WDG Herbicide when ornamentals are under stress from insects, diseases, animal or any other stresses.
- Care should be taken to ensure plants are tolerant to a *SureGuard* WDG Herbicide application. Ornamentals not listed on this label may tolerate an application of *SureGuard* WDG Herbicide, but *SureGuard* WDG Herbicide must be applied to each species in limited areas prior to an operational application.
- Do not apply more than one application of 8 oz of *SureGuard* WDG Herbicide per acre over-the-top of dormant ornamentals in a single year.
- Do not apply *SureGuard* WDG Herbicide directly to plant foliage while growth is actively growing.
- Do not apply *SureGuard* WDG Herbicide when weather conditions favor spray drift from treated areas.
- Do not tank mix *SureGuard* WDG Herbicide with any other pesticide.
- Do not apply *SureGuard* WDG Herbicide through any type of irrigation system.
- Do not mechanically incorporate *SureGuard* WDG Herbicide into soil after application.
