WATER RUN: Apply 40 gallons with every acre foot of water applied up to a maximum of 140 gallons of Soilcal per acre per year.

GYPSUM SUPPLEMENT: Apply 10-15 gallons per acre with every ton of gypsum used to a maximum of 140 gallons of Soilcal applied per acre per year.

LISTED FOR ORGANIC APPLICATIONS AS FOLLOWS: Apply at rates recommended by local agricultural experts as a foliar spray to treat a physiological disorder associated with calcium uptake.
