DIRECTIONS FOR USE

Apply to turf at a rate of 5 to 10 pounds per 1,000 sq. ft. (for a maximum application rate of 50 pounds per 1,000 sq. ft. per growing season) to generate good color without promoting unwanted top growth. Watering in is recommended for quicker response and better granule dispersion and is particularly recommended when application has been made to moist turf so spotting or staining does not occur. Apply to turf mowed to one-half inch or less only at the lower rate and only after testing to make sure unwanted spotting, staining, or phytotoxicity does not occur. Watering in thoroughly is recommended. Reapply as necessary to maintain desirable color.

ORNAMENTAL USE:

For chlorosis of azaleas, rhododendrons, or evergreens, apply 2 tablespoons of PERK per foot of plant height or 4 pounds per 1,000 sq. ft. Apply uniformly around plant drip zone. Watering in will speed the effects of the product.

For general landscape use, apply 1 tablespoon per foot of plant height or 2 pounds per 1,000 sq. ft. Water in thoroughly to remove any particles from the leaf surface and to activate product.

CAUTION - Iron will stain concrete and clothing. Sweep or blow, do not wash particles off concrete sidewalks. Any clothing that has contacted the product should be washed separately to make sure stains are not transferred to other clothing.
