Apply only as directed during the growing season.

For use on greens and tees where a high potash fertilization is desired. Potash fertilization may improve turfgrass resistance to stress.

#### Application Rates:

LOW: 1.90 lbs./1,000 sq. ft.  
MEDIUM: 3.80 lbs./1,000 sq. ft.

#### For all applications:

- Apply to dry turf and water in immediately with a minimum of 0.2 inches of water.
- Apply at the MEDIUM RATE
- Exception: Apply at the LOW RATE if temperatures are 85°F (30°C) or above. Make repeat applications as necessary.

Watering in this product will disperse each granule into thousands of particles. This will facilitate the movement of the nutrients into the soil. This particle dispersion will also eliminate ball, shoe and mower pickup - minimizing fertilizer loss.

Store in a clean, dry place.  
Reseal opened bag by folding top down and securing.  
Use only clean, dry spreaders.
